I AM VOLUNTARILY PARTICIPATING IN THE EVENT AND I EXPRESSLY AGREE TO ASSUME THE ENTIRE RISK OF ANY ACCIDENT OR PERSONAL INJURY, INCLUDING DEATH WHICH I MIGHT SUFFER AS A RESULT OF MY PARTICIPATION IN THE EVENT, WHETHER SUCH RISK RESULTS FROM NEGLIGENCE (EXCEPT WILLFUL NEGLIGENCE) ON THE PART OF ANY OR ALL OF THE RELEASED PARTIES.

For the purpose of implementing this release, I expressly acknowledge that this release is intended to include all claims which the parties do not know or suspect exist in their favor at the named of the executions hereof, including specifically, without limitation, those described in section 1542 of the California Civil Code, which section reads as follows:

"A general release does not extend to claims which the creditor does not know or suspect exist in his favor at the time of executing the release, which if known by him must have materially affected his settlement with the debtor."
